## **TERMS AND CONDITIONS**

**The Devasthanams Educational Officer, T.T.D (2<sup>nd</sup> Floor, TTD Press) K.T.Road, Tirupati** invites sealed tenders from registered Farmers associations for **supply of Vegetables to the TTD College attached Hostels and other TTD Institutions** for a period of one year and renewable on yearly basis on evaluation by TTD not exceeding 03(three) years. T.T.D desires to procure Vegetables on the day to day rates prescribed in Rythu Bazaar, Tirupati and transportation charges per trip as quoted by the lowest Tenderer.

### **1.Terms of Reference :-**

The Qualitative Requirements of this contract are as follows: The farmers associations who fulfil the following criteria are eligible to be evaluated, and the associations who do not fulfil the following conditions will be summarily rejected and the decision of the TTD is final.

The tenderer has to supply vegetables to the TTD College attached hostels & other TTD Institutions at the rates approved by Rythu Bazaar, Tirupati only.

a. Must be in existence in the field of sales and supply of Vegetables for the last 03 (three) years.

**b. Must be able to supply approximately 1870 Kgs per day of different varieties of vegetables to TTD Educational Institutions hostels and other TTD Institutions at Tirupati.**

- a. **Own Vehicle:-**Should have own vehicle on hand to transport vegetables and good track record of service with reputed organizations (furnish proof). Proof of Satisfactory performance must be enclosed.
- b. Should be in a position to undertake the supply within 15 days from the date of acceptance/finalization of tenders by T.T.D.
- c. Earnest Money deposit is exempted.
- d. Security Deposit of Rs.1,00,000.00 (Rupees one lakh only) shall be paid by the successful tenderer by way of Demand draft from any of the Nationalized banks at the time of agreement.



2. The Successful Tenderer shall supply the required Vegetables to the following TTD College attached Hostels and other TTD Institutions at Tirupati/Tirumala for a period of one year from the date of awarding the supply order.

- (15) SV Ayurvedic College Hostel, TTD, Tirupati.

The sealed covers shall be superscribed as **"Tenders for supply of Vegetables to TTD's College attached Hostels and other TTD's Institutions"** and will be received up to 3.00pm **on 02.11.2019** and opened on 04-11-2019 at 3.00 pm in the chamber of the Devasthanams Educational Officer, TTD, Tirupati in the presence of Officers authorized by the Executive Officer, T.T.Devasthanams, Tirupati.

**3.** The Vegetables should be supplied to the respective TTD College attached Hostels and other TTD Institutions in suitable containers in good condition.

4. The Security Deposit amount will be refunded only after satisfactory completion of the contract period. The amount, if any due, to TTD will be

recovered from Security Deposit. No interest will be paid on the Security Deposit amounts.

5. The successful Tenderer should supply fresh vegetables of good quality as per time schedule (to be communicated to him) and also the quantity as per the indents placed by the concerned Principal/Chief Warden/authorised Officials. The quality and freshness of Vegetables should conform to the satisfaction of the Devasthanams Educational Officer/Principal/Chief Warden/other officials as the case may be.

**6. The successful Tenderer should collect the indent everyday from all TTD College attached Hostels and other TTD Institutions i.e., a day before the supply of Vegetables.**

7. The successful Tenderer should supply vegetables continuously whenever required to the Institutions throughout the Tender period and bear all the expenditure such as toll fee, taxes etc, if any levied by the Govt., till the vegetables reach the destination.

8. If the supplied Vegetables are not up to the standard with regard to quality, weight, freshness etc, during the verification by the concerned / food analyst at the time of delivery of the Vegetables, the same will be rejected and the required Vegetables will be purchased from the open market and the difference of cost if any will be recovered from the successful tenderer while making payment.

9. Any request from the successful tenderer to increase the transportation charges due to increase of fuel rate or due to any other unforeseen circumstances will not be entertained at any cost and there would not be any legality to contest for the issue.

10. The Chief Vigilance and Security Officer, TTD, Tirupati will permit the vehicles transporting vegetables to travel from Tirupati to Tirumala duly collecting the usual toll fee fixed by the TTD from time to time.

11. Transportation of the Vegetables to the TTD College attached Hostels and other TTD Institutions within the stipulated time shall be at the risk and responsibility of the Tenderer and he should make his own transport arrangements.

12. If the Tenderer fails to supply as per the indent placed by the concerned Principals/Chief Wardens penalty will be imposed and recovered from the further bills payable as detailed below.

**Note: a) No penalty will be imposed if they supply is 80% of the indented vegetables or more.**

**b) If the supply is less than 80 % (i.e 61% to 79%) of the indented vegetables, 15% of the total bill amount will be deducted as penalty.**

**c) If the supply is less than or equal to 60% and less than the indented vegetables, 25% of the total amount will be deducted as penalty.**

13. If the Farmers Association fails to supply the vegetables on any day, the required vegetables will be purchased from Rythu Bazaar, Tirupati / open market. The amount will be deducted from the future bills as a measure of penalty.

14. The successful Tenderer shall execute an agreement with all the terms and conditions specified on a Non-judicial stamp Paper worth of Rs.100/-(Rupees One hundred only) before the commencement of the contract.

15. The Devasthanams Educational Officer & The Executive Officer, TTD reserves the right to reject or accept the Tenders without assigning any reasons therefor.

16. All disputes (if any) arising with regard to these Tenders shall be settled within Tirupati Jurisdiction, Andhra Pradesh only.

17. **The Tenderers should quote their rate per trip for transportation of vegetables both in figures and in words.** Any over writing, erasers and alterations in the Tenders rate will not be admitted, unless they are attested by the dated initials of the Tenderer.

18. The Tenderers who have dues to TTD and the persons having criminal record, persons whose earlier Tender was cancelled for violation of terms and conditions of Tender are liable to be summarily rejected. And if it comes to the notice of the T.T.D. at a later date that a particular Tenderer is having any of the above disqualifications, then the Tender orders issued will be cancelled immediately without any prior notice duly forfeiting the Security Deposit paid by the tenderer.

19. The rates quoted shall be inclusive of all levies. The rate for transportation charges should be shown separately as given in the price bid and the same shall be continued during the contract period.

20. Notwithstanding anything contained in the terms of offer by Tender, any suit with regard to any matter whatsoever arising out of this contract, shall be instituted in any court within the jurisdiction at Tirupati, Andhra Pradesh.

21. The TTD reserves the right for inclusion or exclusion of the other terms and conditions in the interest of TTD without specifying further intimation.

## **22.TenderSchedules:-**

Tender schedules are available in the office of the Devasthanams Educational Officer (2<sup>nd</sup> Floor, TTD Press Compound) TTD, K.T.Road, Tirupati during office working hours i.e., from 10.30 AM to 5.00 PM on payment of Rs.500/-(rupees Five Hundred only), which is non-refundable, by way of Demand draft drawn in favour of "THE EXECUTIVE OFFICER, TTD" from any scheduled bank between 21.10.2019 and 02.11.2019. **The Tenderers will deposit the Tender schedules**

**on 02.11.2019 upto 3-00 P.M. and the same will be opened at 3-00 P.M on 04.11.2019.**

**Note:-THE COST OF TENDER DOCUMENT IS NOT REFUNDABLE.**

**23. SECURITY DEPOSIT :**

a) Every Tender schedule must be accompanied by a crossed demand draft for Rs.1,00,000/- (Rupees one lakh only) payable on any nationalized Bank at Tirupati drawn in favour of " The EXECUTIVE OFFICER, TTD, TIRUPATI" towards refundable Security deposit.

**24. RATES:-**

The rates quoted for transportation shall be inclusive of all toll fees and levies as given in the Price Bid and the same shall be followed during the contract period. The rates once accepted shall not be changed during the period of contract under any circumstances.

The rates should be written in figures and words and the Tenders with overwriting, alterations etc., would not be admitted unless they are attested by the competent authority. Where there is discrepancy between the rates in figures and in words, rate in words will govern.

**25. DOCUMENTS REQUIRED FOR PAYMENT:-**

a. Consolidated Monthly Bill along with advance stamped receipt shall be submitted to the respective Principals of college attached hostels with regard to payment of Vegetable bills

b. The claim of bills should be raised in the name of the Farmer Association only.

c. A statement with day wise bill No. and bill amount, duly authenticated by the respective Wardens/officials.

d. A statement with indent, supply & non-supply during the month.

e. Any other documents like PAN card and Bank details etc. as required from time to time.

The above documents required are not exhaustive and it is to be specifically noted that without the above documents, the bills of farmer association shall not be processed by the TTD. Statutory deductions as per rules will be borne by the Tenderer and they will be deducted from the monthly bill.

26. The Executive Officer/ Devasthanams Educational Officer, TTD, Tirupati reserves the right to give preference to any farmer association in the interest of the organization at any time before and after the acceptance of the tender and their decision is final and binding on Tenderer without any recourse.

27. The TTD reserves the right to terminate and recover liquidate damages from the Tenderer for failing to fulfil the terms of the contract as detailed below:

a) In case the successful Tenderer backs out/ withdraws after releasing the letter of intent or fails to supply vegetables within the period to be prescribed by the Devasthanams Educational Officer, TTD, Tirupati at the time of placing orders, the firm will be liable to make good the loss sustained by the TTD in addition to the following as under.

b) TTD shall be entitled to choose the farmer association or any other agency without notice to the tenderer who has failed to supply the Vegetables as per the requirement at the first instance and to recover the extra cost thus incurred from the tenderer.

c) TTD also reserves the right to cancel the contract or portion thereof and the decision of the Executive Officer/Devasthanams



Educational Officer shall be final and binding on the parties without any recourse.

d) TTD reserves the right to forfeit the Security Deposit to the extent of the loss incurred by TTD in the event of action being taken under (a) & (b) and of any short fall, the TTD shall be at liberty to recover such amount with legal charges, if any from the tenderer by instituting a civil suit.

28. TTD reserves the right to charge penalty as decided under clause 11 or withhold payment for any unsatisfactory service rendered by the farmer association without prejudice to its other rights. In this regard, the decision of the Devasthanams Educational Officer, TTD is final.

29. All prohibitory items applicable to TTD as a whole and in sacred Tirumala Hills in particular have to be followed strictly by the farmer association. Further it is to inform to the Tenderers that, under **Section 114 of Act 30 of 1987** any person contravening any prohibitory items in this regard shall be punishable by the TTD/Law.

i) Possession, use or consumption of any intoxicating liquor or drug or cigarettes and other prohibited items ;

ii) Possession, preparation or consumption of meat or other food stuffs containing meat;

iii) Slaughter, killing or maiming any animal or bird for any reason;

iv) Gaming with cards, dice, counters, money or other instruments of gaming;

v) Dealing in any manner with Seva ticket, Prasadam and accommodation belonging to the Tirumala Tirupati Devasthanams except at such places and by persons specially authorized in this behalf by him.

30. Tenderer is required to sign the declaration on Tender forms in duplicate indicating date and affixing the rubber stamp with the designation or status enjoyed by the signatory in the firm and the same signatory shall be required to execute agreement under his signature only. The signatory should produce documentary evidence of empowering him to do so, if called upon at any time during the contract period. In case change of the person of the signatory it is bound on the Tenderer to inform the changes to the TTD.

### **31. PAYMENT:-**

The payment will be made as per the daily rates fixed by Rythu Bazaar, Tirupati by the end of the month by way of cheque only. All statutory deductions applicable at the time shall be made from the payment. No advance will be paid against the supplied vegetables.

Note : The rates available in Rythu Bazaar website will be taken as criteria (or) certified by the Estate Officer, Rythu Bazaar, Tirupati.

With regard to the payment towards Vegetable supply, the concerned Principal has to pay to the supplier as per the claim of the contractor and with regard to the Transportation the DEO, TTD has to pay to the contractor as per No. of trips travelled in a month basing on the certificate received from the Dy.EO Nityhyannadanam, TTD.

### **32. SUB-CONTRACTING:-**

The contract work awarded should be executed by the successful Tenderer only and sub-contracting of the work is not permitted. Further, the contract or any part of the contract is not to be transferred.

### **33. INDEMNITY:-**

The Tenderer shall at all-time indemnify the TTD against all claims which may arise in respect of accidents, any loss, harm, damages which is caused due to dereliction of duty of the Tenderer.

34. If the Tenderer fails or neglects to comply with any of the terms and conditions of the contract or with any order issued thereunder, then, in such a case, the TTD shall without prejudice to any other right or remedies under this contract as a right and be entitled to cancel the contract by giving a notice in writing to the supplier without being liable to pay any compensation for such cancellation. Further, the Tenderer will be put in blacklist.

35. The Farmer association/ Agency/ Firms who apply for these Tender documents have to furnish the declaration that **"They have not been black-listed in any Organizations"**. Any wrong declaration in this regard which comes to the notice at a later date will disqualify them from Tenders in future in TTD and the Tenders so received shall be automatically disqualified.

36. The TTD reserves the right to accept or reject any Tender and to cancel the process and to reject all Tenders at any time prior to the award of the contract without assigning any reasons and also it is under no obligation to inform the affected Tenders the grounds of acceptance or rejection of the same. In this regard, the decision of the Executive Officer/ Devasthanams Educational Officer, TTD, Tirupati is final and binding on the Tenders without any recourse. Further, it is specifically be accepted by the Tenderer when the Tenderer files the Tenders before TTD that the acceptance or rejection of the Tenders by TTD or methodology adopted by TTD in short listing agency for the supply of vegetables shall not become a cause of action or ground for the Tenders to initiate any legal action before any court or courts of Law for obtaining any order, injection, direction etc., from the Honorable Court or Courts to stall the proceedings in TTD.

## **TENDER RULES**

**The Devasthanams Educational Officer, (2<sup>nd</sup> Floor T.T.D Press compound) K.T.Road, Tirupati** invites applications from registered farmers associations for the supply of Vegetables to TTD's college attached hostels and other TTD Institutions at Tirupati on contract basis at the rates approved by Rythu Bazaar, Tirupati for a period of one year, and renewed if required on yearly basis on evaluation by TTD not exceeding 03(three) years. T.T.D desires to procure Vegetables at the rates approved by Rythu Bazaar, Tirupati and transportation charges as quoted by the lowest Tenderer.

### **1.Terms of Reference :-**

The farmers associations who fulfill the following criteria are eligible to be evaluated and the associations who do not fulfill the conditions will be summarily rejected and the decision of the TTD is final and binding on the Tenderer without any recourse.

- a. The tenderer has to supply the vegetables to TTD's college attached hostels and other TTD Institutions at Tirupati at the rates approved by Rythu Bazaar, Tirupati only.
- b. Must be in existence in the field of sales and supply of Vegetables for the last 03 (three) years.
- c. Must be able to supply approximately **1870** Kgs of different varieties of vegetables **daily** to TTD's college attached hostels and other TTD Institutions at Tirupati **Own Vehicle:-**Should have own vehicle on hand to transport vegetables and good track record of service with reputed organizations (furnish proof). Proof of Satisfactory performance must be enclosed.
- d. Should be in a position to undertake the supply within 15 days from the date of requisition by the T.T.D.
- e. Earnest Money deposit is exempted.
- f. Security Deposit of Rs.1,00,000/- (Rupees one lakh only) shall be paid by the successful tenderer by way of Demand draft from any of the Nationalized banks at the time of agreement.

## **2. Cost of Tendering:-**

The Tenderer shall bear all costs associated with the preparation and submission of the Tender. The TTD will not be responsible or liable for these costs, regardless of the conduct or outcome of the Tender process.

## **3. Bid documents:-**

The Tender documents include:

1. Tender Notice
2. Declaration by the Tenderer
3. Tender Rules
4. Terms and Conditions of the Contract
5. Price Bids

The Tenderer is expected to examine all instructions, forms, terms and specifications in the Tender Documents. Failure to furnish all information required as per the Tender Documents or submission of Tender not substantially responsive to the Tender Documents in every respect will be at the Tenderer risk and may result in rejection of the Tender.

## **4. Clarification of Tender Documents:-**

A Prospective Tenderer, requiring any clarification of the Tender Documents shall notify TTD in writing or by Phone at the TTD mailing address indicated in the Tender Notice. TTD shall respond in writing to any request for clarification of the tender Documents, which is received not later than 14 days prior to the date for the submission of Tender. Copies of the query (without identifying the source) and clarification by TTD shall be sent to the entire prospective Tender who has received the bid documents.

Tender must be received by TTD at the address specified in Tender Notice not later than the prescribed time on the due date. **Tender schedules shall not be received by post/courier.** Tender schedules are not transferable.

Tenderers shall drop the sealed Tender covers in the Tender box kept in the following address.

**5.Amendment of Tender Document:-**

5.1 At any time, prior to the date of submission of Tender, the TTD may modify the tender documents by amendments for any reason, whether at its own initiative or in response to a clarification requested by a prospective tenderer.

5.2 The amendments shall be notified in writing to all prospective Tenderers on the address intimated at the time of purchase of tender document from TTD and these amendments will be binding on them.

5.3 In order to afford prospective tenderers reasonable time to take the amendments into account in preparing their Tenders, TTD may at its discretion, extend the deadline for the submission of bids suitably.

**6. Tender Form:-**

The Tenderer shall complete the Tender forms and the appropriate price schedule for transportation charges furnished in the Tender Documents.

**7. Bid Prices:-**

7.1) Prices indicated on the Price Bid shall be entered in the following manner:-



a) The price quoted for transportation shall be total price inclusive of all toll fees and levies payable to the bidder and FOR delivery at T.T.D Educational Institutions at Tirupati as mentioned in the Tender.

b) The tenderer shall quote only one price for transportation and if more than one price is quoted under different options the rate quoted by him in the first option only will be valid and will be taken for evaluation as per price schedule given in the schedule of requirement.

c) The prices quoted by the Tenderer shall remain fixed during the period of contract, subject to revision of rates if any by TTD. A Tender submitted with an adjustable price, is likely to be treated as non-responsive and rejected.

d) The price quoted by the Tenderer shall be in sufficient details to enable TTD to arrive at prices of proposed rates offered.

## **8. Tender eligibility and Qualifications:-**

8.1 The Tenderer shall furnish as part of his Tender documents establishing the Tenderer's eligibility all the following documents or whichever is required as per terms and conditions of Tender documents.

- i. Farmers association registration certificate.
- ii. PAN number
- iii. 3 years experience certificate in supply of vegetables.
- iv. Should have capacity to supply **1870 Kgs of vegetables per day** (Approximately).

## **9. Submission of Tenders:-**

9.1) The offer shall be submitted in sealed cover for the service to be provided. The covers should be superscripted with the heading **"TENDER FOR SUPPLY OF VEGETABLES TO TTD College attached Hostels and other TTD Institutions .**

9.2) The envelope containing **Technical Bid** should include the whole of this Tender documents other than the price schedule duly signed by the tenderer along with the farmer association Profile and standard printed technical literature/ brochure about the association with connected certificates of testimonials, registrations etc., which are all required for evaluating the bid as mentioned in S.No-8 along with the Technical Bid.

9.3) The envelope containing **Price Bid** should include only the Tender price for the services offered (as per the format enclosed). Please note that no other information other than price (rate) should be furnished along with this offer.

9.4) The two envelopes of technical and price bids for the services rendered as above shall in turn be put in a outer envelop sealed and superscripted "Technical and price bids for supply of Vegetables". The sealed outer covers should be addressed to the Devasthanams Educational Officer, (2<sup>nd</sup> Floor, TTD Printing Press compound) Opposite TTD Administrative building, K.T.Road, Tirupati -517501.

9.5) The Tender with over-writing, alterations etc., will not be admitted unless they are attested by the Tenderer. Tender should be neatly written and every correction should be invariably be attested by full signature with date before submission of Tender to the authority concerned, failing which the quotations will not be eligible for further consideration. Errors, if any will be corrected/ accepted by Tender accepting authority at its discretion. Telegraphic and Pencil Tender will not be accepted. Unsigned Tender forms will be rejected.

9.6) TTD may at its discretion extend the deadline for submission of the bids by amending the bid documents in accordance with Clause 7 in which case all rights and obligations of TTD and bidders previously subject to the deadline will thereafter be subject to the new deadline as extended.

9.7) Tenderers should submit the tender duly signed in each & every page and should also mention that the conditions of the tender are thoroughly studied by the tenderer and Tenderer is agreeing to the conditions. Otherwise, his tender will be rejected.

#### **10.Late Tenders:-**

**Any Tenders received by TTD after deadline for submission of Tenders prescribed by TTD pursuant to Clause 9, shall be rejected and returned without opening of the Tender.**

#### **11. Opening of Tenders by TTD:-**

11.1) The TTD shall open Tenders in the presence of Tenderers or their authorized representatives who choose to **attend at 3.00 pm on the due date**. The representatives of the Tenderers, who are present, shall sign in an attendance register. The Tenderers shall submit authority letter to this effect before they are allowed to participate in bid opening.

11.2) A maximum of two representatives for any tender shall be authorized and permitted to attend the tender opening.

11.3) The names of the Tenderers and any other details as the TTD at its discretion may consider appropriate, will be announced at the time of opening of Tenders.

11.4) If the date fixed for opening of Tenders is subsequently declared as holiday by the TTD, the revised date of schedule will be notified.

#### **12. Clarification of Bids:-**

To assist in the examination, evaluation and comparison of Tenders, TTD may at its discretion ask the Tenderer for clarification of its Tender. The request for clarifications on the response shall be in writing. However, no post Tender clarification at the initiative of the Tender shall be entertained.

#### **13. Preliminary Evaluation:-**

TTD shall evaluate the bids to determine whether they are complete, whether any computational errors have been made, whether required sureties have been furnished, whether the documents have been properly signed and whether the bids

are generally in order. All certificates pertaining to the previous contract shall be enclosed with the Tender schedules. No further opportunity will be given to the Tenderer for providing technical and any other details.

If there is any discrepancy between words and figures, the amount in words shall prevail. If the supplier does not accept the correction of the errors, his bid shall be rejected.

#### **14. Contacting TTD:-**

Subject to Clause 12, no Tenderer shall try to influence TTD on any matter relating to its Tender from the time of the Tender opening till the time the contract awarded.

**Any effort by a Tenderer to influence TTD in the TTD Tender evaluation, Tender comparison or contract award decision shall result in the rejection of his Tender.**

#### **15. Placement of Order:-**
