NOTICE INVITING EXPRESSION OF INTEREST

For **"Procurement of Passenger Vehicle Screening and Scanning system to Install at**
Sapthagiri Check Point, Alipiri, Tirupati

Preamble:

The Vigilance and Security Department in Tirumala Tirupati Devasthanams is one of the major Departments to look after entire Vigilance & Security aspects of the TTD's Temples and its properties. The Security measures of Sri T.T., Tirumala is a matter of great concern to TTD. The existing deployment of Security systems as well as manpower is throwing up the following challenges:

- a). Waiting time at Alipiri for vehicles to be checked is ranging between half an hour to one hour approximately.
- b). Need for Strict security measures as with latest technologies and state of art equipments.
- c). During rush days most of the pilgrims, who come from faraway places with tiresome journey feels inconvenience due to existing security measures especially old aged, women and parents with small children and reluctant to co-operate with the security personnel to get down with their luggage from their vehicles / buses.
- d). Due to large number of pilgrims in each bus, each station for handling a bus have a dedicated luggage scanners to scan luggage.

However, both times, the frisking is urgent need to ensure systematic frisking and checking one final time before they enter into the main temple by re-engineering the process.

After thorough examination of existing structures, systems, limitations and requirements it is thought of for modifications. Checking of vehicles is felt mandatory to allow pilgrims to Tirumala, which is causing considerable delay in clearing vehicles at Alipiri Check point. This is ultimately resulting in resentment among the pilgrims.

Now, the TTD is planning to introduce Passenger Vehicle Screening and Scanning system to install at Sapthagiri Check Point, Alipiri, Tirupati to strengthen security and for the convenience of visiting Pilgrims to Tirumala.

With this as a back ground and also keeping in view of recent terror attacks in religious places like Srilanka, it is proposed to invite Expression of Interest from the reputed firms / Reputed Agencies / Individuals having relevant experience in this field with Passenger Vehicle Screening and Scanning system solution or any for proper screening and scanning of vehicles for not to allow vehicles with luggage with prohibited items and contra banned items to Tirumala.

Scope of Work:

- Automatic detection of concealed threats and contraband for high throughput and high performance detection.
- Combined search/scan for optimum throughput, random alarm generation to include additional screening procedures, audio signal alert with throughput, scan count, user access, and other operational parameters are automatically recorded by the system.
- Eco-scans a large three dimensional volume that ensures full coverage of the vehicle being screened.
- Multi-material detection-reveals any concealed objects such as metals, ceramics, plastics, liquids, narcotics, etc.
- Automated checking of the operational process is integrated into the system thus ensuring that the correct screening procedures are to be implemented.
- Minimal footprint—allows for easy integration into existing checkpoints
- Instant output of detection results
- Simple scanning procedure supports rapid processing of people through the checkpoint
- The complete activity should be executed in respective Alipiri Check point itself under proper supervision of Vigilance & Security officials.
- The tenderer shall ensure that there shall not be any nuisance or damage to such existing structure at Alipiri check point while execution of the said activity.
- It is recommended that the Tenderer may carry out proper study before for necessary data acquisition before bidding.
- The tenderer shall make their own arrangements for required man power and equipments for installation of Passenger Vehicle Screening and Scanning system.
- The deployment of the dedicated team for executing the project to be indicated while presenting the scheme for approval or at PPT stage to assess the competence of the bidder.
- The bidder has to submit the tentative Program Evaluation Review Technique (PERT) at PPT stage.

Eligibility Criteria:

1. Firms having experience in Passenger Vehicle Screening and Scanning system Technologies successfully.
2. Should furnish Liquid Assets and / or credit facilities of not less than Rs. 2 Crores (Rupees Twenty lakhs only) (credit facility / letter of credits / solvency certificates from Banks etc not older than one year).
3. Proof of Registration of the firm from the competent authority.
4. Profile of the Technical personnel on the roles of the firm.
5. Any added qualification if required to be added.
6. The EOI document can be down loaded from www.tirumala.org and furnished by enclosing a DD of Rs. 5,000/- (Non Refundable) (Rupees Five thousand only) in favor of Executive Officer, Tirumala Tirupati Devasthanams (TTD) towards the cost of EOI .
7. EMD of Rs. 50,000/- (Rupees Fifty Thousands only) in favour of Executive Officer, TTD payable at Tirupati by way of DD.(Refundable in the case of un successor tenderers)
8. The following documents are required to be submitted along with the tender.
 - a) PAN card of the firm
 - b) GST Registration certificate.
 - c) Experience Certificates / Work orders / Agreement copies issued by the reputed Public / Private firm in the relevant field.
9. If the EOI offer is submitted through Joint Venture / Consortium, the details of the lead partner, technology provider, Share of lead member shall be clearly mentioned along with enclosing copy of the Joint Venture / Consortium Agreement.

PRE-BID MEETING:

- As a part of the bidding process a pre- bid meeting will be held in the office of the Chief Vigilance and Security Officer, TTD, Administrative Building, K. T. Road, Tirupati. Participation of potential tenderers in this meeting though not mandatory, is encouraged. This meeting will provide an opportunity to the Prospective tenderers to seek any clarification or explanation on the EOI, scope of services to be provided, bidding process or any other matter important to the Prospective tenderers.

- In the interest of productiveness of the pre-bid meeting the tenderers are requested, as far as possible, to submit any questions in writing, and the Minutes of the meeting, including the text of the questions raised and the responses thereto, will be transmitted without delay to the Prospective tenderer and also a copy of the same will be placed in TTD website (www.tirumala.org).

Note: The tenderer may communicate their queries / clarifications on or before 1.00 Pm on 25-11-2019 to cvsoofficettd@gmail.com or represent them in the pre-bid meeting. After pre-bid meeting no clarifications will be considered.

Contract Period:

The successful tenderer will execute a Contract with TTD for installation of Passenger Vehicle Screening and Scanning system for a period of 6 months (contract period) duly depositing a security deposit or further EMD by way of DD which is equal to the value of 2.5% of the contract value [equivalent for a period of 6 months], as the case may be. Further, the tenderer has to renew the security deposit till the expiry of Contract period.

Note: Based on the business proposal proposed and submitted, the agency / firm can propose the contract period in the financial bid.

Bid offer and Evaluation:

- The selection process involves submission of 2 bid system i.e., Technical Bid and Financial Bid.
- The application shall be in two covers. In the Technical bid, Cover – I contains qualification criteria (Annexure –I) in the financial bid Cover – II contains (Annexure-II)
- The tenderer shall submit the declaration as mentioned in Annexure – III and enclose the same in Technical Bid of qualification criteria in Cover -I.
- The Technical Bid shall invariably be enclosed with a Demand Draft from any nationalized banks for an amount of Rs. 50,000/- (Fifty Thousand Rupees Only) drawn in favor of “The Executive Officer, TTD” payable at Tirupati.
- The Last Date of Submission of document with required copies of Qualification and Experience, in sealed cover containing a) the sealed cover containing qualification criteria under technical bid as per Annexure – I, the sealed cover containing the financial bid as per Annexure – II, should reach the following address within 3.00 PM on or before dt: **04.12.2019**. The technical bid will be opened on the same day at 3.30 PM or on the subsequent day.
- A Committee will be formed to evaluate the details (qualification criteria) and methodology of installation of Passenger Vehicle Screening and Scanning system furnished by the tenderer (Cover – I & II) and the tenderers whose technical bid is found satisfying the eligibility criteria will only be considered for opening of financial bid.

TECHNICAL BID: (Cover- I)

Qualification Criteria (Cover – I)

- The technical bid containing qualification requirements as per Annexure-I will be evaluated by the evaluation committee.
- TTD shall have the right to call for clarification / original copies of the supporting documents for verification, as deemed fit and also to cross check for any details as furnished by the consulting firms. The firm shall have no objection what so ever in this regards.

FINANCIAL BID: (Cover-II)

- The tenderer shall submit his financial bid duly indicating all the details
- Further, TTD at any point of time can seek clarifications on the submitted Financial bid.
- The Financial Bid of the tenderers whose Technical Bid are qualified will only be opened.
- The decision of evaluation committee shall be final and binding on the tenderers.

Award criteria:

- All the details shall be mentioned in the financial bid. However, the offer / bid which is more beneficial to TTD will be selected by the evaluation committee. The bid / offer submitted shall be evaluated based on details / steps until completion of complete work.
- As per the recommendation of the evaluation committee, the Addl. Chief Vigilance and Security Officer / Vigilance and Security Officer, TTD, Tirupati will award or recommend to the competent tender accepting authority for award of the contract to the Tenderer who is found technically qualified as per the Tender conditions and whose price bid is the lowest / Beneficial to TTD.

- On selection of a Successful tenderer, TTD will notify him through a Letter of Award (LoA) that his Proposal has been accepted.
- The Successful tenderer shall execute the Contract within 10 days of the issue of LoA or within such further time as TTD may agree to, at its sole discretion along with performance security.
- The Successful tenderer shall also furnish further EMD by way of Demand Draft in favour of Executive Officer, TTD, as mentioned in Contract Period.
- The EMD of unsuccessful tenderers will be returned within a period of 10 days from the date of signing of Contract by the Successful Bidder.

Terms and conditions:

- Only one application will be allowed on behalf of each tenderer.
- Applications without required information or enclosures are liable to be rejected.
- TTD reserve the right, in their sole and absolute discretion to amend the scope of the project, modify, cancel or suspend EOI process or reject the EOI bid at any stage / at any time for any reason.
- Applications received after due date will not be entertained.
- Any conditional offer will not be accepted.

Jurisdiction :

- This (EOI) document will be construed and governed in accordance with the laws of India, Any dispute arising out or in connection with the bidding process shall be settled within the jurisdiction of Courts of Andhra Pradesh.
