# EOI called for on the Scope of Work for lifting of garbage from various points of Tirumala to the transit stations / Bio waste processing unit, Tirumala

The proposals are to invite Expression of Interest (EOI) with Methodology / Detailed project report by on line from interested persons / major players associated with the Solid Waste Management considering various factors and practices presently being followed to implement an advanced and better methods of Garbage lifting and Transportation from various points of Tirumala to the transit stations / Bio waste processing unit, Tirumala in an aesthetic manner in hygienic way with minimal human interference duly following the guidelines of Solid Waste Management Act of 2016 for implementation on Tirumala under Swacha Survekshan (Swacha Bharat Mission) to maintain clean & hygienic peripherals of Tirumala areas to avoid inconvenience to the visiting pilgrims with the following scope of work.

- 1. 2960 dust bins primary collection points are there wherein Two / Three 100 liter dust bins are kept for primary storage of Dry / wet waste.
- 2. Dry waste & Wet waste are to be separately shifted from various points of Tirumala to the Bio waste plant at Kakulamanuthippa, near Gogarbam Dam Tirumala(Wet Waste) and transit station for dry waste sorting station.
- 3. The Garbage at the initial point is to be sorted out as Biodegradable & Non-Biodegradeble and to be shifted for further disposal (Dry, Wet & Biohazard)
- 4. Hygienic/Body covered with back loading tippers are to be used with minimum man power for lifting of the garbage as per pictures enclosed or better models.
- 5. The present Bio waste processing is also not confirming to the norms of Solid Waste Management Act of 2016 that also have to be reviewed and better model to be adopted.
