## (i) Food Additives:

For products covered under this standard, specific food additives permitted in Appendix 'A' (FCS 6.1 no additives permitted) of these regulations may be used and only within the limits specified.

## (ii) Contaminants, Toxins and Residues:

The product shall comply with the limits stipulated under the Food Safety and Standards (Contaminants, toxins and Residues) Regulations, 2011. The product meets specifications of Heavy metals (2.1.1, Lead, Arsenic, Cadmium Mercury), Aflatoxins (2.2.1, total aflatoxins, Aflatoxin B1) and pesticide residues (2.3.1, banned pesticides) to be met.

- 2. The packing of commodity should be also in accordance with the provisions of packaging Act to avoid damages in transit. It should also contain marking to denote address, date of packing etc., for identifications given below. Otherwise, the entire lot will be rejected. The packing should be marked as "FOR TTD USE". The printed matter on the bags should be in English / Hindi / local language and should not contain any other language.
- 3. The labelling declaration of **Sojji** shall be as per Food Safety and Standards (Labelling and Display) Regulations, 2020. All the tenderers shall abide by the requirements as per Chapter 2, Labelling Requirements of Prepacked foods. The requirements includes:

- 14. Details of Allergens (if any).
