1	Size: 41 X 46 cms (Before folding width 41 X 46 cms length after folding width 24X 46 cms length)
2	Capacity: To put 10 to 15 Nos. of Laddus and shall bear 4 Kgs of weight.
3	Handle : U' shape handles (with width not less than 40 mm wide for the handles) with side folding and printing matter on both sides.
4	Thickness: Thickness of covers should not be less than 50 microns .
5	It should be Ghee, Oil and Moisture Proof & also be Water proof.
6	Odour: The film shall be free from any objectionable odour and should not impart any odour to the Laddus.
7	Appearance <ol style="list-style-type: none"> 1. The film should be uniform in color, texture finish. The material to be substantially free from pin holes, undispersed raw materials, streaks and particles of foreign matter. 2. There should be no other visible defects such as holes, tears or blisters. 3. The edges should be free from nicks and cuts visible to unaided eye.
8	Print: <ol style="list-style-type: none"> 1. To Print "Tirumala Tirupati Devasthanams, Tirumala" "SRI VARI PRASADAMU" in different languages on both sides of the bag as required by the TTD. Printing should be in food grade. 2. To print valid CPCB license Number, QE Code etc., as per norms on the bag
9	Migration : as per IS-10146/ IS 9845 shall not exceed 10 mg per DMSq.
10	Compostable film to be used for making bag/cover: <ol style="list-style-type: none"> 1. Should be made from Poly lactic Acid (PLA) / Polybutylene Adipate Terephthalate (PBAT) based material. 2. Should be completely food grade and non-toxic in nature. 3. The film must dissolve in dichloromethane solvent 4. The film to be converted into ashes upon burning.

1. The bidders who are desirous of participating in e-Tender shall register online as per procedure and also to upload the following documents in the website of <https://tender.apecurement.gov.in/>.
 - a. Certificates demonstrating experience for at least in any one year of the last three financial years as per Proforma (Annexure). Invoices shall be uploaded.
 - b. Registration of the firm.
 - c. GST registration
 - d. PAN card & Income Tax returns for the last preceding 3 financial years.
 - e. Self-declaration certificate (Annexure-B).
 - f. Declaration agreeing to abide all the terms and conditions of tender as per (Annexure-A)

- g. 20 samples shall be submitted at the time of tender and Annexure -C.
 - h. Supply of the relevant commodity experience in proof of evidence of supplies made to the different organizations in each year of last three preceding financial years period (proof of clear invoices/ way bills showing experience should be uploaded).
 - i. Self-Declaration letter to the extent that they have not been black listed in any of the organizations.
- 2. The Tenderer should upload E.M.D. paid through ONLINE.
 - 3. Shall furnish the certificate showing that, the tenderer is an authorized manufacturer of the Bio Compostable Covers
 - 4. The tenders should submit the license/ registration certificate that the firm is enlisted by Central Pollution Control Board (CPCB), New Delhi to manufacture, marketing and selling of the compostable covers.
 - 5. Shall furnish a valid analysis test report as per IS 17088:2008 / IS 17088:2012 / IS 17088:2021 by CIPET as per guidelines of CPCB taken at the time of establishment of the firm
 - 6. **Shall enclose the Latest Test report from any NABL accredited Lab (reports shall be taken within 2 months prior to the date of publication of tender) confirming to TTD intended specifications meeting the following tests (failing which, will be summarily rejected)**
 - a. **Physical parameters as per TTD specifications(as mentioned in above table)**
 - b. **FTIR/DSC tests**
 - c. **Solubility in dichloromethane**
 - d. **Film shall be converted into ashes upon burning (Burning test)**
 - e. **Migration test as per IS-10146/ IS 9845**
 - 7. **The Lab Reports older than 2 months from the date of tender publication will not be accepted.**
 - 8. Annual turnover statement (more than Rs.2.00 crore) in any one year of the last three preceding financial years to be furnished to be certified by chartered accountant.
 - 9. The entire document of NIT should be signed by the authorized representative of the firm and the same should be submitted to online.
 - 10. The tenderer should furnish documents (invoices / e-way bills) for the past experience of supplying of 10 Lakh Nos / 15,000 kgs of the similar product of Bio Compostable Covers (any size) to different organizations in any one year of the last 3(three) financial years.
