EXPERIENCE CRITERIA

- n) Attested copies of Registration Certificate and License from the licensing officer under Contract Labour (Regulation and Abolition) Act, 1970 to carry out FMS as described earlier.
- o) List of full-time key-employees with qualifications, experience (only senior & middle management) and the number of years of service in the organization.
- p) Attested copies of Income Statement and Balance Sheet of the firm/company and Turnover from FMS activities for the last 5 (five) years **2016-17 to 2020-21**)
- q) List of equipment along with manufacturer details and number of units that will be deployed for the work.
