3. The duly filled-in Tender Schedule shall be dropped in the **Tender Box** kept in the Office of the **Assistant Executive Officer (Revenue), TTD Administrative Building, Tirupati**, on **26.08.2026**, between **10.30 AM and 3.00 PM**.
4. The Tender Box will be opened on **26.08.2026 at 3.30 PM** in the presence of the Committee Members and tenderers or their authorized representatives who wish to be present
5. The cost of the Tender Schedule is **non-refundable**.
6. Tenders received after the prescribed date and time or without the prescribed documents shall be **summarily rejected**.
