1.	<b>Fabric :-</b> 100% Cotton, 110 Gsm, Color - Natural
2.	<b>Size:-</b> Width x Length 12x14 Inches (30.48x35.56Cms)
3.	<b>Accessories:-</b> Butter Paper (30 ± 2 GSM) would be placed inside the bag not to absorb Ghee & oil which controls stains on the cloth bag.
4.	<b>Capacity :-</b> This Bag will Carry not less than 10 Laddus and shall bare a weight up to 4 Kg with food grade.
5.	<b>Branding:-</b> This bag shall have a logo of TTD printed on both the sides.
6.	<b>Handle:</b> U shaped handle with length x width 6 x 5 inch
7.	<b>Butter Paper :</b> Must be Food Grade
8.	Printing should be in food grade.
9.	Printing matter will be decided by TTD.
